"Capitalism has brought with it progress, not merely in production but also in knowledge" These words highlighted by the delegate of France, quoting the widely acknowledged physicist Albert Einstein echoed in the room as the first session for the crisis committee began. To formally start the discourse, the delegate of the

Soviet Union honoured the lives that were changed, pressing on the fact that the soviet union did not start the war and the benefits of the communist ideology. However, the The delegate of the USA questioned this, asking how a communist government can be held accountable. The delegate of France also pressed on how communist governments are unable to implement the principles of their ideologies, which is clear from the fact that capitalist nations are far ahead than the communist ones. As several similar statements were thrown around the room, the deliberation was interrupted by the beginning of The Korean War. Only further developments and discussions can determine the course of the committee.



"It is not enough to win a war, it is more important to organise peace."

This line as stated by Aristotle holds true with the agenda raised in the United Nations Security Council i.e. the promotion of sustainable peace and security in conflict-affected regions emphasizing on the

problems faced by the Middle East countries.

The Chair leading the committee is Mr. Siddhant Nair and by his side the Vice Chair of the committee as Miss Aarushi Dixit.

The Chair kept mentioning the Delegate of USA to give examples to the delegates in the committee stating, "I am not favouring any of the P5 country here. Is everyone okay if I mention Delegate of USA as our example?"

The delegate of USA mentioned that USA needed to cut ties with any conflict causing countries and offended Russia.

The Delegate of India stated," Middle East countries are the main suppliers of oil and natural gas hence conflicts need to be resolved at the earliest."

The Delegate of Japan strongly stated that the civil wars had always been backed up by foreign powers and also added that 80% of the population had gone under the poverty line. USA raised a Point of Enquiry for Mexico about increasing number of refugees in the country to which Mexico explained it was the effect of covid-19.

The Delegate of Saudi Arabia confidently mentioned that Syria had lack of income stability and that Saudi Arabia had provided aid. Contradicting this Japan enquired "How is your country carrying out air strikes if you are promoting peace?" Delegates were irresponsive!!
