Before starting with the committee the chairs briefly explained to the delegates about ROPs for UNA/USA. They made it easier for the delegates to understand them by giving great explanations that they won't ever forget and entertained many questions from delegates with great enthusiasm and intense energy. For a committee to work efficiently with double delegation could only be possible if the delegates are aware of the rules and procedures and have a good brief about the agenda, and later on the reason for why the agenda was chosen to be discussed in the committee and with a motive to encourage the delegates not to be neutral towards the agenda and have a clear stance as Israel-Palestine is a sensitive topic for almost every country and no country has shown support to just one of the country in particular, After the briefings were done the committee began with a roll call and later on the agenda was established by the delegate of Africa. The delegate of the USA established a motion, to begin with, the general speaker's list, but later on, the delegates were distributed among themselves, and three blocs were made, the first bloc was anti-Israel, the second bloc had a neutral stance and lastly, the third block was pro-Israel and after the distribution, The United Kingdom gave the first GSL with great power but no sense as a country who says that they believe in peace but are known as the colonizers of the world, they also got a question from the executive board about how UK made a



peace treaty for both the countries when UK had colonized both of them in the past. The next GSL was given by the delegate of Ecuador, mostly stating its stance on how they've supported Palestine in the past with aid but their president and vice-president had consolidated with Israel after the Gaza attack, after this speech the motion was raised by the delegate of South Korea to adjourn the committee.

After the lunch break, the third gsl was given by the delegate of France, again promoting the idea of a two-state policy and concluding that Israel and Palestine make peace in the future. The fourth speech was given by the delegate of Japan, showcasing their support towards Hamaz and that they take refugees but the questions asked by China eradicated the statement as from recent sources Japan has stopped taking

any more refugees moreover USA blamed them how they have their own territorial disputes and they want to make peace in between israel and palestine. Surprisingly USA raised a Point of order on China clarifying that Japan does accept refugees on their quality, later the delegate of china raised a motion to move into an unmod for 10 minutes. Overall as of now the committee has indulged in many debates and topics to discuss on with great arguments.

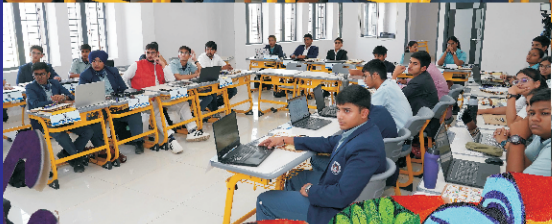
Finally, the Quorum is established and the committee proceeds into formal debate. A GSL is taken of the speakers interested to deliver their speeches, each unique on its own.
