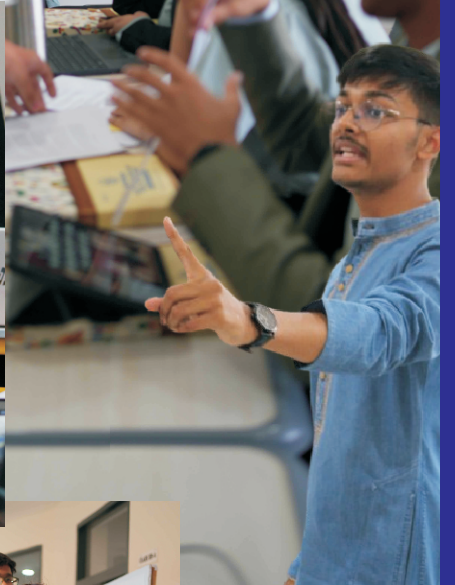

Today the committee began with a roll call, and later on, delegates added their name to GSL, a GSL should never dissolve or the committee will be forced to end. The GSL began with the first delegate being from Sierra Leone and was questioned about its problem with hunger strikes, how it was providing aid for Palestine, and its experience with blood diamonds fuelling conflict and promises of mines to be built, justifying it with a naive answer and no proving that the delegate did not research. The next speech was given by the delegate of Switzerland, the delegate comprehensively emphasized how they helped Palestine with funds supporting its local authorities in the Gaza Strip and encouraging others to do the same. A motion was raised by the delegate of China to go into an unmod for 10 mins. From China stating that Taiwan is a secular part of their country to the USA stating that NATO is just a trade organization, to Guyana concluding that Hamaz is a governmental organization that would hurt the sentiments of the Israeli govt if they don't follow what they do in the first committee session, Today's committee has some expectations to hold.



After the unmod, a motion was raised by the delegate of France to move into a mod on the topic of religious identities in genolism including historical regions, but the topic was questioned by EB on how irrelevant their topic was and needed to be modified. Later modified to the relevance of religious identities in genolism including historical regions with respect to the ongoing crisis. The first speaker was the delegate of Guyana who emphasized that they support the two-state policy and its religious rights. The next speech was given by the delegate of China and concluded with the point of how respect for both religions should be provided and they should exist in harmony, the delegate was questioned about its communist policy that religion is a disease and also going against the policy of their country, and another question about their Uyghur Muslims that the delegate answered effortlessly. The third speaker was the delegate of

South Korea, contradicting the fact that both beliefs matter and should be respected, moreover was questioned about a report passed by the Korean govt. about alcohol and division that even if it is considered haram increased the delegate blamed it on the new K-pop culture. The fourth speaker was the delegate of Algeria who acknowledged the same as how they support their religious beliefs and historical places, later got inquired about its Armenian Azerbaijan, proving their statement was false about how their countries live in peace while the president believes that some Muslims are better than others. The fifth speech was by the delegate of the UK, the delegate was questioned about why there was an increase in racial activities about how Jesus was a Muslim, in London, the UK blamed it on public opinion but the EB denied the claim as the Chairperson was in UK last week, the delegate of UK left stunned.

The next speech was spoken by the delegate of Malta, emphasizing the fact that citizens of a place should live in peace, and got questioned about its neighboring countries but Russia answered the question like everything is theirs in Europe, The next speech was by the delegate of Japan that started with a Konichiwa, the delegate concluded about the importance of religion in genolism and concluded with a great poem at the end, later on the next speech was given by the delegate of USA who spoke how every religion matters and the importance about the historical rights but got questioned about the statements by their ex-president regarding the Mexican wall and how they call themselves the land of opportunities yet only for a few immigrants of Mexico, the delegate for the first time unable to answer.

After the mod ended, GSL started again and the first speaker was the delegate of Qurana who gave a moderate speech. Surprisingly a guest speaker entered the committee that was the delegate of Israel, who stated

that the first attack was done by Palestine in Hamaz and expressed their concerns for their country. Moreover blamed Hamaz for rape rallies that went on for a whole week of little children, concluding on the fact that Islamicism is poison for their country and how for justice of their country and people they will end the war started by Palestine, moreover the delegate also called out the countries of the west and how they blame Islam for the attacks but hide the fact that the hospitals that they bombed were armed with weapons and how Palestine bombed the Israeli borders. The delegate of Israel was inquired by a lot of delegates, one of them was Algeria complimenting the strong army of Israel, moreover, Israel was blamed for war crimes but the delegate doesn't believe in the sources that were provided for the justification of the same. Israel was accused of bombarding and islamophobia but the delegate of Israel dogged all the claims and answered with no hesitation.

Overall, today's committee session lived up to its hype and had a very smooth flow.





CRISIS COMMITTEE

The delegate of The USA set the agenda for the committee Ad Hock as deliberation on the Russia-Ukraine war concerning equitable resource allocation. Later the EB explained the ROPs for how a crisis committee works and set a mandate for the committee on economics and set the conduction as UNA/USA format and worked on the flow of the committee as ECOSOC and the delegates will add their names in a an ESSL. The committee works on article 377. The motion was established by the delegate of Finland to establish the ESSL. The first speech was given by the delegate of Ukraine, concluding on articles and providing humanitarian rights for Ukraine quoting from the UN charter and setting up of agency to monitor funds and blaming Russia on an article for inhuman treatment towards Russia and got asked about what the govt. Is doing it for the safety of their The question was answered effortlessly yet again blaming the delegate of Russia, ukraine was questioned about its fund that was allocated to the photo shoot of the president, and the delegate replied that it was done for spreading awareness, The next speech was given by the delegate of Russia who gave justification of their actions and war, moreover blamed the western world and suggested Ukraine to not join the NATO. This controversial speech led to Right To Reply:

a. Right to reply from USA to Russia, and Russia refused to apologize.

b. Right to reply from Ukraine to Russia, and Russia refused to apologize.

Later on, the delegate of Russia was questioned by the delegate of the USA that Russia's solution was like a donut sugar coated from the outside but with a deep hole in the middle, The delegate of Russia was left stunned. The third speech was given by the delegate of Libiya, supporting Ukraine, the delegate was questioned why

they didn't support Russia yet they are allies and supported Ukraine but their president said that they are not a part of NATO and they work with Russia, creating more tension in the committee. The fourth speech was given by the delegate of Madagascar, concluding that Russia should back out from the war and should now provide humanitarian aid for Ukraine, which is practically impossible cause just suggesting a country do something during wartime is negotiably impossible. The delegate of Norway gave the fifth speech, highlighting that every nation should be transparent and provide assistance for Ukraine, as they require help from Western countries. The sixth speech was given by the delegate of Filipines, suggesting to assist Ukraine and how they've provided resources concluding that everyone should work together to resolve the dispute between the nations. The second last speech was given by the delegate of Canada, conveying how they've over time provided funds for Ukraine and encouraging other nations to do the same. The delegate of Nigeria gave the last speech, the delegate emphasized the fact that Ukraine has no more resources for economic growth and that its healthcare resources have fallen over time, moreover, Ukraine needs to be provided with funds. As the speech came to an end a citizen living in Ukraine came and expressed their distress about the war and inhuman attacks from Russia that have killed the citizen's whole family and blamed the USA for not using its powers to stop the war and clarifying that it is useless for a nation like the USA to sit in a committee silently like that, with this the committee was adjourned and the final working paper will be submitted by the delegates by the end of the session. Overall the committee was very engaged with each other through debates and discussions, the crisis committee was a success.

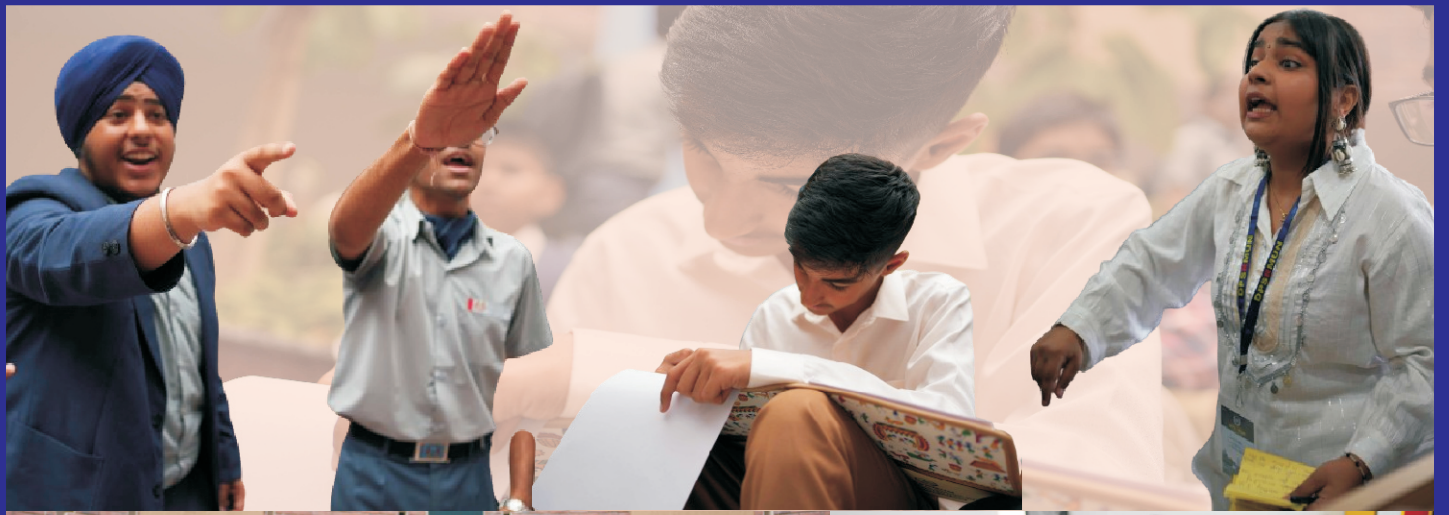
