## The United Nations Security Council

Agenda: Solving the Israel-Palestine conflict with deliberation on the necessity of UN peacekeeping operations in the area

A great start for the committee today by the first GSL by the delegate of Ecuador, expressing its concern towards the conflict and suggesting a two-state policy respecting both of the conflicted countries. Onwards to the next speech by the delegate of Switzerland, recognizing the struggles of both countries and again concluding on the two-state policy. The third speech by the delegate of Malta energized the whole committee with a speech with great power and information. The fourth speech by the delegate of South Korea emphasized how heartbreaking the war is for the citizens of both countries, mostly sympathizing with Israel, the delegate was questioned about how their own country is facing religious matters and answered effortlessly. The next speech by the delegate of France concluded that they stood with the two-state policy.

The sixth speech by the delegate of Guyana emphasized the international war crime laws and how it can resolve the conflict, got questioned about its water disputes with Venezuela and refugee policy, more importantly, the delegate of Guyana being pro-Palestine, is completely against the policy of The USA but during times of need Guyana taking help of The USA is justified by the delegate as two separate matters and policies, a great irony. The delegate of China raised a motion to go into a mod caucus on the topic of solutions for how to help the Israel-Palestine conflict. The first few speeches given by the delegate only emphasized how the countries should be at peace and how two-state policy, during the speech of the delegate of Russia, the delegate mentioned how peace is the solution, however making it an irony as Russia is itself in a war with Ukraine. The speech given by the delegate of The USA, who mentioned policies about the UN charter and great resolutions to the problem, but as always great solutions have great questions to justify, but the delegate as always answered them with no effort. After the speech given by the delegate of Switzerland, the delegate was inquired about why the motion raised by the delegate of the USA was not voted in support of the delegate as they support new treaties like these, the delegate of Switzerland apologized for going against the delegate's words. The rest of the speeches given by the delegates were moderately focused on the common solutions mentioned before and the blame game. The end of the mod brought about some new solutions yet mainly emphasizing the two-state policy. After the GSL given by the delegate of Algeria, a brief by the EB was given on how to format a Draft Resolution as a DR is a formal document that concludes with the solution to resolve the agenda of the committee, usually in a committee like UNSC, for a resolution to pass in almost impossible. As of now the committee has shown great progress in the resolvent towards the agenda and emphasizing the topics that matter with great controversies and and debates.



**Draft Resolution** - The first DR was introduced by the delegate of The USA called draft resolution 1.1. The draft was spoken by the delegate of USA and Switzerland. The DR passed quickly with no amendments or changes by the other bloc, moreover during the time for voting the delegate of China used veto power and scraped the DR. The opposition bloc expressed their anger by shouting "SHAME!SHAME!SHAME!"

**The Draft Resolution 1.1:-** Sponsors: Republic of Korea, Swiss Confederation, The Republic of Malta, The United Kingdom of Great Britain and Northern Ireland, The United States of America Signatories: The French Republic, the State of Japan, The People's Democratic Republic of Algeria, The Republic of Ecuador, the Republic of Sierra Leone

1) Suggests the establishment of a Trusteeship Council, in accordance with Article 85 of the United Nations Charter, to oversee the transition period towards the establishment of a fully sovereign and independent Palestinian State, and calls upon the Secretary-General to convene an international conference to determine the modalities and mandate of the Trusteeship Council, with the participation of all relevant stakeholders: a) Condemns the actions of Hamas and recognizes the PLO as the sole official representative of the Palestinian people;

2) Condemns all acts of violence, terrorism, provocation, incitement, and destruction, and calls for immediate cessation of all hostilities, including rocket fire from Gaza, and calls for full respect for international humanitarian law, including the protection of civilians, especially children;

3) Calls for the immediate cessation of settlement activities, demolition of Palestinian homes, evictions, and the forcible transfer of civilians, in violation of international law;

4) Reiterates its call for the lifting of the blockade on Gaza and the opening of border crossings, and calls for the facilitation and access to humanitarian assistance to the Palestinian civilian population in Gaza, in accordance with international humanitarian law;

5) Calls upon the international community to provide urgently needed humanitarian assistance and support to the Palestinian people, including through UN agencies and other relevant organizations like the Red Cross and Doctors Without Borders;

6) Calls upon both parties to refrain from unilateral actions that undermine the prospects for a two-state solution, including

annexation of territory, and reaffirms that the establishment by Israel of settlements in the Palestinian territory occupied since 1967 including a plebiscite and provision of dual citizenship, organized by the Trusteeship Council and including East Jerusalem, which has no legal validity and constitutes a flagrant violation under international law;

7) Stresses the importance of achieving a just, comprehensive, and lasting peace in the Middle East, based on relevant United Nations resolutions 242 (1967), 338 (1973), 1397 (2002), 1515 (2003), 1850 (2008), and 2334 (2016), and calls for the resumption of negotiations between the parties, with the support of the international community, towards the achievement of a two-state solution, where Israel and Palestine live side by side in peace and security, co-existing within recognized borders;

8) Suggests the deployment of a United Nations peacekeeping mission assisted by the sponsors and signatories of this resolution to monitor and enforce peace agreements and promote dialogue between Israel and Palestine;

9) Directs the UN Special Rapporteur on freedom of religion or belief for resolving the issue regarding allegedly illegal settlements in either Israel or Palestine;

10) Calls upon the UN High Commission of refugees to rehabilitate the refugees displaced by the actions of the entity mentioned in the previous clause;

11) Proposes the following amendments to UN Charter: **a)** Article 80: The rights of the Palestinian people to their territory and resources within the region shall be protected under international law, any agreements or arrangements that infringe upon these rights shall be deemed null and void; **b)** Article 109: The United Nations shall have the authority to convene a General Conference of its Members to deliberate on amendments to the Charter aimed at strengthening the two-state solution for the Israeli-Palestinian conflict, these amendments shall ensure accountability for violations of international law, and promote the peaceful coexistence of both Israeli and Palestinian states.

But as for the Draft Resolution for the delegate of China during the passing of the motion, the opposition bloc didn't let the motion pass and the motion failed, concluding the committee UNSC was a very active committee with great delegates but more importantly an amazing Executive Board. The committee was a great success.

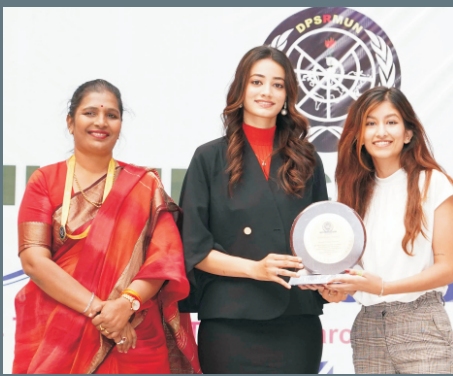

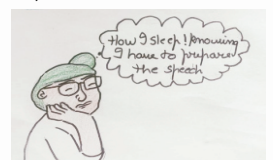
All the delegates made commendable DRs which were mailed to the EB. Everyone then headed towards Lunch

AGENDA : Developing Strategies To Increase International Burden-Sharing By Improve Resettlement Options And Facilitating The Integration Of Refugees Into Host communities

I am a courageous spirit,

I am unaware why and what caused them to inflict such hate

I can't stop thinking about the reason; it is taken to my heed.



The poem given above mentions a refugee who is discriminated against and persecuted by particular groups, when he just wants to seek a sheltered land, to find his peace. He is also desperate to finally hear good news-that is- an arrangement of resettlement where they won't be facing any troubles and to take his brothers , sisters and comrades ( the other refugees who are seeking resettlement and asylum) along with him. Many asylum seekers and refugees dream quite similarly, but, on the contrary- only few are able to live it. Continuing with what was left of Day 2 in the UNHCR, delegates spoke on 2 moderate caucuses :-'Discussion upon literacy and skill development of refugees' and 'Developing sustainable solutions for acceptance of refugees into host communities'. Both topics were raised by the delegation of France. About 8 GSL's were taken.

On day 3, that is the final day of this MUN- in UNHCR, The utmost true commitment towards the productivity and of the agenda was seen. After the executive board demonstrated on the structure of a DR, Delegates took a deep dive into the sea of determination. 2 blocs were formed, namely 'Plight Resolvers' and 'Maverick Minds'. They presented their respective direct Draft resolutions. 14 GSL'S were taken.

The First to present their DR were the 'Plight Resolvers' who named their DR , 'Draft Resolution 2.0' the sponsors of the DR were the delegation of The French Republic, The Republic of India, The Russian Federation and The Kingdom of Denmark. The delegate of the USA pointed out the incorrect names of countries in the signatories. Unfortunately the DR, 'Draft Resolution 2.0' was scrapped and not considered due to the lack of confidence in the sponsors. This was followed by loud thumps and bangs on their desks made by the other bloc.

Maverick Minds were second to present their DR, named 'Draft Resolution 1.11' . That too, was discontinued due to errors in the format. This might probably be the first time 2 draft resolutions were discontinued in such a short amount of time due to misconception. The Chairperson gave disappointed looks towards the nations and thus planned that an unmoderated caucus of total time being 2 minutes in order to revisit and edit the DR would continue after Venezuela's GSL. After the GSL and the unmoderated caucus, the chairperson advised both blocs to number their DR's correctly.



This MUN was a rollercoaster for the delegates, in which delegates were faced with many challenges, but they were trying to overcome the same by putting their best efforts. Delegates were very active throughout the committee sessions on all three days and surely learnt from their mistakes.

### PRESS CONFERENCE: HYPOCRISY OF FRANCE IN THE UNSC ON ISRAEL-PALESTINE CONFLICT.

Interviewer (Aditri Kashyap): France supports Palestine and believes that is Israel is doing wrongful towards the Muslim people of Gaza but on the contrary, it doesn't let Muslims in its own country be given the full freedom to practice their religion openly. They are required to maintain 'public order'. One such example is :- Hijab bans in the public schools of France. How can you justify your statement in this case?
